# 2027 TEXAS STALLION STAKES SERIES TERMS AND CONDITIONS

- 1. All nominated stallions must be Accredited Texas Stallions standing in Texas for the 2024 breeding season.
- 2. The progeny of nominated stallions do not have to be Accredited Texas-Bred nor foaled in Texas to participate in the Texas Stallion Stakes Series.
- 3. The total nomination fee shall be \$1,500 or the advertised stud fee, whichever is greater.
- 4. Stallions must be fully paid into the program in order for foals to be eligible for race nomination.
- 5. If a stallion owner/nominator fails to pay the whole nomination fee, plus applicable penalties, by October 1, 2024 the stallion shall be considered ineligible. Any nomination fees already paid are nonrefundable. Stallions whose owners have failed to make full payment will be footnoted on TSSS foal nomination lists and lists of eligible TSSS stallions as having defaulted.
- 6. Any stallion owner/nominator who fails to pay the whole nomination fee plus any applicable penalties by October 1, 2024 and wishes to enroll their stallion in any Texas Stallion Stakes Series after the 2024 breeding season must pay all fees in full at time of nomination for said Series.
- 7. The TTA reserves the right to postpone or change the conditions of all or any part of the 2027 Texas Stallion Stakes Series without any liability. The 2027 Texas Stallion Stakes Series may be canceled without notice and TTA shall have no liability except to refund all paid nominations without interest.
- 8. In the event that the progeny of any nominated stallion are ineligible for any reason whatsoever to run in the 2027 Texas Stallion Stakes Series, no refunds will be paid to stallion nominators. Stallion nominations are made with the express understanding that no assurances are being given with regard to entry of progeny in any Texas Stallion Stakes races, beyond eligibility for nomination to the program.
- 9. Texas Stallion Stakes races shall be run in compliance with the racing rules and regulations of the Texas Racing Commission, the Texas Thoroughbred Association and the host racetrack.
- 10. All stallion owners/nominators must be TTA members in good standing at time of nomination, and through all races in the 2027 Texas Stallion Stakes for 2-year-olds and older.
- 11. The Texas Stallion Stakes Series is entirely separate from the Accredited Texas-Bred Program. Enrollment in the ATB Program does not constitute automatic enrollment in the Texas Stallion Stakes Series.
- 12. Ten percent (10%) of stallion participation fees and foal nominations will be deducted for TTA administration of the Texas Stallion Stakes Program prior to purse distribution.
